- 14 exploration licenses in the Yilgarn Craton in Western Australia (which are prospective for hardrock lithium);
- Ungranted claims at the Black Mountain Lithium Project in Wyoming, USA (prospective for hardrock lithium); and
- Ungranted claims at an undisclosed location in in Africa (prospective for hardrock lithium).
